SITE INSPECTION NOTES

ONLY PERSONNEL ESSENTIAL TO COMPLETING THE JOB SAFELY WILL BE PERMITTED TO PARTICIPATE IN THE EVOLUTION. ONLY PERSONNEL PARTICIPATING IN THE SAFETY BRIEF WILL BE PERMITTED TO BE IN THE AREA OF OPERATIONS. ONLY AUTHORIZED ESSENTIAL PERSONAL WILL BE PERMITTED IN THE IMMEDIATE AREA OF OPERATIONS. IN THE EVENT AN UNAUTHORIZED PERSON ENTERS THE OPERATIONS AREA OR A POTENTIAL HAZARD IS IDENTIFIED THE PILOT WILL HOLD THE AIRCRAFT IN RELATIVE POSITION. THIS WILL BE ACHIEVED WITHOUT OVER FLYING THE GROUND CREW. ALL OPERATIONS WILL BE CEASED UNTIL THE PROBLEM IS RECTIFIED. IN THE EVENT OF AN AIRCRAFT EMERGENCY, THE PILOT WILL RADIO GROUND PERSONNEL AND WILL ATTEMPT TO LAND IN THE EMERGENCY LANDING AREA. ALL BUILDINGS IN THE OPERATING AREA WILL BE VACANT.

DURING THE LIFT EVOLUTION THE AIRCRAFT AND GROUND CREW WILL ALL BE IN RADIO COMMUNICATIONS. IN THE EVENT OF LOSS COMMUNICATIONS, THE CREW WILL USE STANDARD HAND SIGNALS TO COMMUNICATE WITH THE PILOT. WHEN THE PILOT IS CLEAR HE WILL MOVE THE AIRCRAFT TO A SAFE LOCATION TO ALLOW THE COMMUNICATION PROBLEM TO BE RECTIFIED.

THE OPERATIONS AREA IS WITHIN THE SECURED AREA. ALL ESSENTIAL CREW WITHIN THE OPERATIONS AREA WILL NOT BE INVOLVED IN TAKING PICTURES OR ANY OTHER USE OF CELL PHONES.

PRIOR TO EACH OPERATIONAL DAY A SAFETY TAILBOARD WILL BE CONDUCTED AT THE STAGING AREA

- 1. THE HELICOPTER WILL CONDUCT A HOVER HOOK UP OF THE LONG LINE AT ESTRELLA DRIVE.
- 2. THE POLES WILL BE STAGED OFF OF ESTRELLA DRIVE ON THE DOWN HILL SLOPE
- 3. THE EMERGENCY LANDING AREA ON ESTRELLA AVE. ADDITION THE OPEN AREA BETWEEN THE TWO POLE CAN BE USED FOR EMERGENCY LANDING
- 4. TWO HOME WILL BE EVACUATED DURING THE OPERATION
- 5. LAGUNA BLANCA SCHOOL SOUTH OF PALOMA DRIVE WILL BE VACANT
- 6. ALL AREA IN THE SECURE AREA WILL BE UNOCCUPIED.
- 7. PEDESTRIANS WILL NOT BE PERMITTED OPERATING AREA
- 8. STREET CLOSURE DURING OPERATION WILL OCCUR ON ESTRELLA AVE
- 9 SANTA BARBARA COUNTY SHERIFF AND FIRE DEPARTMENT WILL BE NOTIFIED.



We will be working in your neighborhood to upgrade its electrical facilities to provide you a modern and reliable power grid. Your safety is our highest priority during this construction activity. Upgrades in Your Area

We will be using a helicopter to set new utility pole.

What to Expect

To do this your residence must be completely vacated while the helicopter sets the new utility pole. At no time will our helicopter over fly any residence with a load attached.

- Guardian Helicopters primary concern during this operation is the general safety of the general public. We
 recommend measure to ensure the safety and control of any livestock during the period of helicopter
 operations.

It is important to us that our activity presents as little inconvenience to you as possible.
