IN THE EVENT OF AN AIRCRAFT EMERGENCY, THE PILOT WILL RADIO GROUND PERSONNEL AND WILL ATTEMPT TO LAND IN THE EMERGENCY LANDING AREA.. ALL BUILDINGS IN THE OPERATING AREA WILL BE VACANT.

DURING THE LIFT EVOLUTION THE AIRCRAFT AND GROUND CREW WILL ALL BE IN RADIO COMMUNICATIONS. IN THE EVENT OF LOSS COMMUNICATIONS THE CREW WILL USE STANDARD HAND SIGNALS TO COMMUNICATE WITH THE PILOT. WHEN THE PILOT IS CLEAR HE WILL MOVE THE AIRCRAFT TO A SAFE LOCATION TO ALLOW THE COMMUNICATION PROBLEM TO BE RECTIFIED.



A TAILBOARD SAFETY MEETING WILL BE CONDUCTED PRIOR TO BEGINNING ANY HELICOPTER OPERATIONS

THE AIRCRAFT WILL UTILIZE THE FLIGHT PATH IN DIAGRAM TO ENTER AND EXIT THE OPERATING AREA

- 1. THE HELICOPTER WILL EITHER LOWER THE LONGLINE OR CONNECT THE LONGLINE IN A REMOTE AREA AND FOLLOW THE ASSIGNED FLIGHT PATH TO FLY AN EMPTY LONGLINE TO THE OPERATING AREA. THIS WILL BE CONDUCTED WITHOUT OVERFLYING ANY OCCUPIED ROADS AND ANY BUILDINGS. THE HELICOPTER WILL ONLY MAKE ONE ENTRANCE INTO THE OPERATING AREA ALL WORK WILL BE CONDUCTED IN THAT CYCLE.
- 2. FUELING OPERATIONS NOT BE CONDUCTED
- 3. THE POLES WILL BE STAGED AT THE STAGING AREA
- 4. WATER TRUCK IS NOT REQUIRED
- 5. DRIVEWAYS TO EVACUATED ADDRESSES WILL BE CLOSED
- 6. PRIOR TO BEGINNING LIFT OPERATIONS FLAGMAN AND GHI GROUND CREW WILL ENSURE HOMES THAT REQUIRE EVACUATION ARE VACANT. USE THE LIST OF ADDRESSES AND THE DIAGRAM TO MAKE SURE ALL HOMES WITHIN THE OPERATING AREA ARE EVACUATED.
- 7. THE EMERGENCY LANDING ZONE IS AT THE STAGING AREA AND ALONG THE CLEARING ON THE FLIGHT PATH
