

ONLY PERSONNEL PARTICIPATING IN THE SAFETY BRIEF WILL BE PERMITTED TO BE IN THE AREA OF OPERATIONS. ONLY AUTHORIZED ESSENTIAL PERSONAL WILL BE PERMITTED IN THE IMMEDIATE AREA OF OPERATIONS. IN THE EVENT AN UNAUTHORIZED PERSON ENTERS THE OPERATIONS AREA OR A POTENTIAL HAZARD IS IDENTIFIED THE PILOT WILL HOLD THE AIRCRAFT IN RELATIVE POSITION. THIS WILL BE ACHIEVED WITHOUT OVER FLYING THE GROUND CREW. ALL OPERATIONS WILL BE CEASED UNTIL THE PROBLEM IS RECTIFIED. IN THE EVENT OF AN AIRCRAFT EMERGENCY, THE PILOT WILL RADIO GROUND PERSONNEL AND WILL ATTEMPT TO LAND IN THE EMERGENCY LANDING AREA.

DURING THE LIFT EVOLUTION THE AIRCRAFT AND GROUND CREW WILL ALL BE IN RADIO COMMUNICATIONS. IN THE EVENT OF LOSS COMMUNICATIONS THE CREW WILL USE STANDARD HAND SIGNALS TO COMMUNICATE WITH THE PILOT. WHEN THE PILOT IS CLEAR HE WILL MOVE THE AIRCRAFT TO A SAFE LOCATION TO ALLOW

THE COMMUNICATION PROBLEM TO BE RECTIFIED.

THE EMERGENCY LANDING AREA IS LOCATED ON THE PARKING LOT. THE AREA OF OPERATIONS WILL BE SECURED. THE OPERATIONS AREA IS WITHIN THE SECURED AREA. TWO SECURITY PERSONNEL WILL ENSURE FOOT TRAFFIC DOES NOT ENTER THE OPERATING AREA FROM THE PARKING STRUCTURE. ALL ESSENTIAL CREW WITHIN THE OPERATIONS AREA WILL NOT BE INVOLVED IN TAKING PICTURES OR ANY OTHER USE OF CELL PHONES.

- 1. HELICOPTER WILL NOT BE LANDING DURING THE OPERATION. HOVER HOOK UP OF LONG LINE ON THE EDGE OF THE BUILDING.
- 2. THE EMERGENCY LANDING ZONE IS ON THE PARKING LOT TO THE NORTH OR ON THE **STREET**
- 3. NO UNITS ARE CLOSER THAN 110 FT FROM THE EDGE OF THE OPERATING AREA
- 4. IRONDALE AVE AND LURLINE WILL BE CLOSED AT PLUMMER STREET
- 5. THE SUBJECT BUILDING WILL BE VACANT DURING THE OPERATIONS.
- 6. ALL OUTDOOR AREAS WITHIN THE SECURE ZONE WILL BE VACANT.
- 5. NON-ESSENTIAL PERSONAL WILL NOT BE PERMITTED IN THE OPERATING AREA
- 6. STAGING AREA IS IN THE PARKING LOT TO THE NORTH OF SUBJECT BUILDING
- 7. PEDESTRIANS WILL NOT BE PERMITTED IN THE OPERATIONS AREA
- 8. LOCAL AUTHORITIES WILL BE NOTIFIED OF THE OPERATION
- 9. UH-1H WILL FLY TO AND FROM THE PART 133 OPERATING AREA USING THE ASSIGNED AND APPROVED FLIGHT PATH FROM THE RAILROAD TRACKS TO THE JOB SITE AVOIDING FLYING OVER ANY STRUCTURES.




