The Congested Area Plan (CAP) submitted to our office on August 25, 2019, has been approved.

This approval is limited to the proposed operations for the replacement of a ground transformer(s) located at, or near 623 Via Horquilla, Palos Verde Estates, Ca. The approved date of operation is scheduled to commence and cease on September 25, 2019, between the hours of 0740 a.m. and 1941 p.m in a secure area, as defined in the CAP.

The secure area must be strictly, maintained with only the personnel and vehicles that are directly involved with the lift operations, in the secured area. Failure to maintain a secure operational area will be grounds for cancellation of this operation.

Particular attention must be paid to clearing any debris in the attachment area and securing work materials that may be disturbed by helicopter rotor wash.

This approval is contingent upon any authorization and/or permits required by State of California or local authorities. Inspectors from this office may monitor the operation to ensure compliance with the approved plan.

SITE INSPECTION NOTES

ONLY PERSONNEL ESSENTIAL TO COMPLETING THE JOB SAFELY WILL BE PERMITTED TO PARTICIPATE IN THE EVOLUTION. ONLY PERSONNEL PARTICIPATING IN THE SAFETY BRIEF WILL BE PERMITTED TO BE IN THE AREA OF OPERATIONS. ONLY AUTHORIZED ESSENTIAL PERSONAL WILL BE PERMITTED IN THE IMMEDIATE AREA OF OPERATIONS. IN THE EVENT AN UNAUTHORIZED PERSON ENTERS THE OPERATIONS AREA OR A POTENTIAL HAZARD IS IDENTIFIED THE PILOT WILL HOLD THE AIRCRAFT IN RELATIVE POSITION. THIS WILL BE ACHIEVED WITHOUT OVER FLYING THE GROUND CREW. ALL OPERATIONS WILL BE CEASED UNTIL THE PROBLEM IS RECTIFIED. IN THE EVENT OF AN AIRCRAFT EMERGENCY, THE PILOT WILL RADIO GROUND PERSONNEL AND WILL ATTEMPT TO LAND IN THE EMERGENCY LANDING AREA.

DURING THE LIFT EVOLUTION THE AIRCRAFT AND GROUND CREW WILL ALL BE IN RADIO COMMUNICATIONS. IN THE EVENT OF LOSS COMMUNICATIONS, THE CREW WILL USE STANDARD HAND SIGNALS TO COMMUNICATE WITH THE PILOT. WHEN THE PILOT IS CLEAR HE WILL MOVE THE AIRCRAFT TO A SAFE LOCATION TO ALLOW THE COMMUNICATION PROBLEM TO BE RECTIFIED.

THE OPERATIONS AREA IS WITHIN THE SECURED AREA. ALL ESSENTIAL CREW WITHIN THE OPERATIONS AREA WILL NOT BE INVOLVED IN TAKING PICTURES OR ANY OTHER USE OF CELL PHONES.

PRIOR TO BEGINNING OPERATIONS, A TAILBOARD SAFETY BRIEF WILL BE CONDUCTED.

1. HELICOPTER WILL LAND AT THE PV GOLF COURSE IN THE STAGING / FUEL AREA
2. PV GOLF COURSE IS CLOSED DURING THE OPERATIONS
3. FUELING WILL BE CONDUCTED AT THE STAGING AREA
4. EMERGENCY LANDING ZONE IS AT THE STAGING AREA AND ALONG THE FLIGHT PATH
5. VIA COMPESINA AND VIA HORQUILLA WILL EXPERIENCE INTERMITTENT CLOSURES
6. STREET CLOSURE PER DIAGRAM
7. HOMES MARKED WITH A YELLOW "V" WILL BE EVACUATED DURING OPERATIONS
8. STREET CLOSURE PERSONAL WILL VERIFY ALL HOMES ARE EVACUATED PRIOR TO OPERATIONS
9. THE TRANSFORMERS WILL BE LIFTED FROM THE PARKING LOT AT THE GOLF COURSE AND FLOWN ALONG THE FLIGHT PATH TO THE SET SITE. UNIT COMING OUT WILL BE FLOWN ALONG THE FLIGHT PATH TO THE STAGING AREA

10. THE CONTRACTOR WILL TRIM TREES IF REQUIRED

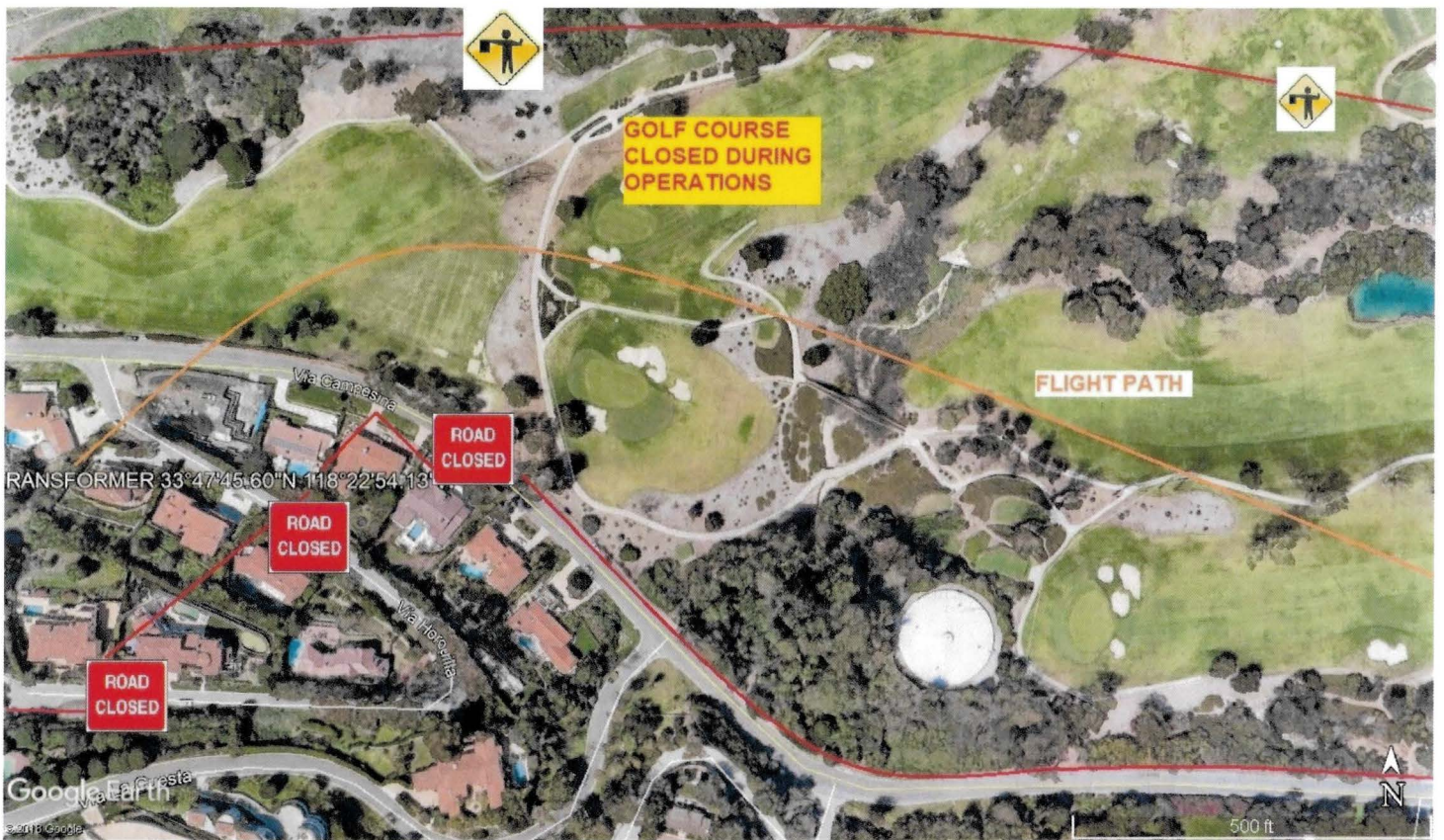
