ONLY PERSONNEL PARTICIPATING IN THE SAFETY BRIEF WILL BE PERMITTED TO BE IN THE AREA OF OPERATIONS. ONLY AUTHORIZED ESSENTIAL PERSONAL WILL BE PERMITTED IN THE IMMEDIATE AREA OF OPERATIONS. IN THE EVENT AN UNAUTHORIZED PERSON ENTERS THE OPERATIONS AREA OR A POTENTIAL HAZARD IS IDENTIFIED THE PILOT WILL HOLD THE AIRCRAFT IN RELATIVE POSITION. THIS WILL BE ACHIEVED WITHOUT OVER FLYING THE GROUND CREW. ALL OPERATIONS WILL BE CEASED UNTIL THE PROBLEM IS RECTIFIED. IN THE EVENT OF AN AIRCRAFT EMERGENCY, THE PILOT WILL RADIO GROUND PERSONNEL AND WILL ATTEMPT TO LAND IN THE EMERGENCY LANDING AREA.

DURING THE LIFT EVOLUTION THE AIRCRAFT AND GROUND CREW WILL ALL BE IN RADIO COMMUNICATIONS. IN THE EVENT OF LOSS COMMUNICATIONS, THE CREW WILL USE STANDARD HAND SIGNALS TO COMMUNICATE WITH THE PILOT. WHEN THE PILOT IS CLEAR HE WILL MOVE THE AIRCRAFT TO A SAFE LOCATION TO ALLOW THE COMMUNICATION PROBLEM TO BE RECTIFIED.

THE OPERATIONS AREA IS WITHIN THE SECURED AREA. ALL ESSENTIAL CREW WITHIN THE OPERATIONS AREA WILL NOT BE INVOLVED IN TAKING PICTURES OR ANY OTHER USE OF CELL PHONES.


PRIOR TO BEGINNING OPERATIONS, A TAILBOARD SAFETY BRIEF WILL BE CONDUCTED.

- HELICOPTER WILL LAND AT THE LZ TO CONNECT THE LONGLINE AND CONDUCT A TAILBOARD SAFETY BRIEF
- 2. POLES WILL BE STAGED AT STAGING AREA
- FUELING WILL OCCUR AT THE LZ
- 4. EMERGENCY LANDING ZONE IS AT THE STAGING AREA AND ALONG THE FLIGHT PATH
- 5. TAILBOARD SAFETY BRIEF CONDUCTED AT THE LZ PRIOR TO FLIGHT
- 6. HUBBARD ROAD WILL EXPERIENCE INTERMITTENT CLOSURES
- 7. SEE DRAWING BELOW FOR LOCATIONS OF CLOSURES
- 8. WATER TRUCK IS REQUIRED
- 9. TWO HOMES WILL BE EVACUATED SEE DIAGRAM ALL HOMES WITHIN 300 FT OF OPERATION AREA WILL BE EVACUATED


THE HELICOPTER WILL LAND AT THE LANDINGS ZONE TO CONDUCT A SAFETY BRIEF. WHEN THE LINE CREW IS READY THE GROUND CREW WILL MAKE SURE THE TWO HOMES ARE EVACUATED. ONCE THE AREA IS CLEAR THE STREET CLOSURE CREW WILL CLOSE HUBBARD ROAD. THE HELICOPTER WILL DELIVER EQUIPMENT BAGS TO THE POLE SITES. WHEN THE CREW IS READY FOR THE POLES THE NEW POLES WILL BE SET IN PLACE AND ONCE ALL 5 POLES ARE SET POLE NUMBER ONE CREW SHOULD BE READY TO REMOVE THE OLD POLE. THE REMAINING 4 POLES WILL BE REMOVED IN ORDER. ONCE THE CREW IS COMPLETE THE HELICOPTER WILL REMOVE EQUIPMENT FOR THE POLE SITES. THE EQUIPMENT

AND OLD POLES WILL BE RETURNED TO THE LZ STAGING AREA. ONCE THE AIRCRAFT IS CLEAR THE ROAD

We will be working in your neighborhood to upgrade its electrical facilities to provide you a modern and reliable power grid. Your safety is our highest priority during this construction activity. We apologize for any inconvenience this may cause and will make every effort to minimize potential impacts during construction activities. Thank you for your patience as we complete these upgrades for you.

Upgrades in Your Area

We will be using a helicopter to set new utility pole.

What to Expect

- Federal Aviation Administration regulations require we take certain precautions to ensure the safety of the public during our operation. To do this your residence must be completely vacated while the helicopter sets the new utility pole. At no time will our helicopter over fly any residence with a load attached.
- HUBBARD ROAD WILL EXPERIENCE INTERMITTENT CLOSURES DURING OPERATIONS
- Guardian Helicopters primary concern during this operation is the general safety of the general public. We
 recommend measure to ensure the safety and control of any livestock during the period of helicopter
 operations.

The timeframe for the evacuation is approximately 120 minutes once all residents have left.

A Guardian Helicopter Inc representative will make contact with you and/or any responsible persons at your residence with further instructions shortly before the aircraft operation is to take place. Please notify all family members, workers, or anyone who may be at your residence on this date of the evacuation. It is important to us that our activity presents as little inconvenience to you as possible.
