ONLY PERSONNEL PARTICIPATING IN THE SAFETY BRIEF WILL BE PERMITTED TO BE IN THE AREA OF OPERATIONS. ONLY AUTHORIZED ESSENTIAL PERSONAL WILL BE PERMITTED IN THE IMMEDIATE AREA OF OPERATIONS. IN THE EVENT AN UNAUTHORIZED PERSON ENTERS THE OPERATIONS AREA OR A POTENTIAL HAZARD IS IDENTIFIED THE PILOT WILL HOLD THE AIRCRAFT IN RELATIVE POSITION. THIS WILL BE ACHIEVED WITHOUT OVER FLYING THE GROUND CREW. ALL OPERATIONS WILL BE CEASED UNTIL THE PROBLEM IS RECTIFIED. IN THE EVENT OF AN AIRCRAFT EMERGENCY, THE PILOT WILL RADIO GROUND PERSONNEL AND WILL ATTEMPT TO LAND IN THE EMERGENCY LANDING AREA.

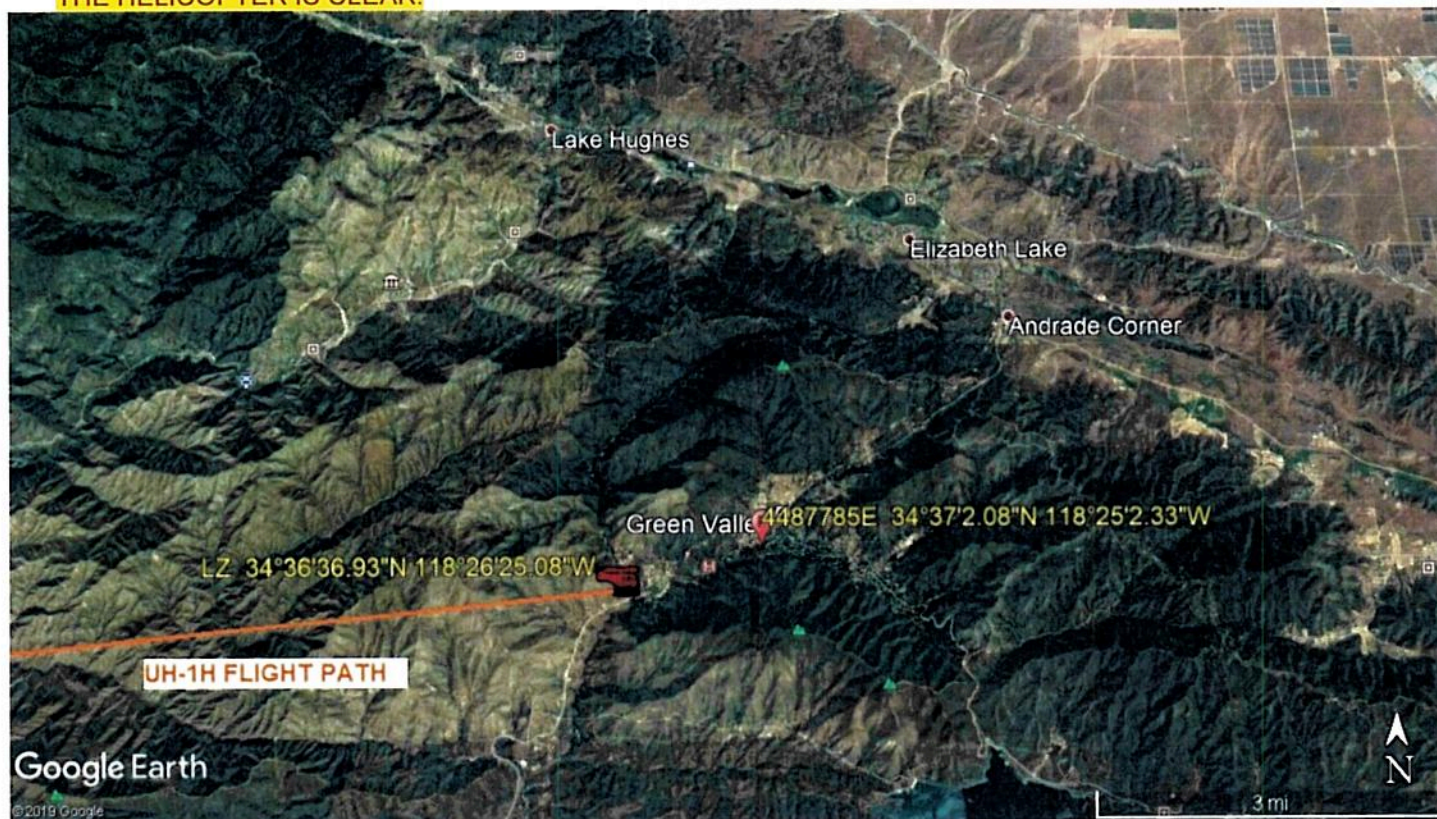
DURING THE LIFT EVOLUTION THE AIRCRAFT AND GROUND CREW WILL ALL BE IN RADIO COMMUNICATIONS. IN THE EVENT OF LOSS COMMUNICATIONS, THE CREW WILL USE STANDARD HAND SIGNALS TO COMMUNICATE WITH THE PILOT. WHEN THE PILOT IS CLEAR HE WILL MOVE THE AIRCRAFT TO A SAFE LOCATION TO ALLOW THE COMMUNICATION PROBLEM TO BE RECTIFIED.

THE OPERATIONS AREA IS WITHIN THE SECURED AREA. ALL ESSENTIAL CREW WITHIN THE OPERATIONS AREA WILL NOT BE INVOLVED IN TAKING PICTURES OR ANY OTHER USE OF CELL PHONES.

PRIOR TO BEGINNING OPERATIONS, A TAILBOARD SAFETY BRIEF WILL BE CONDUCTED.

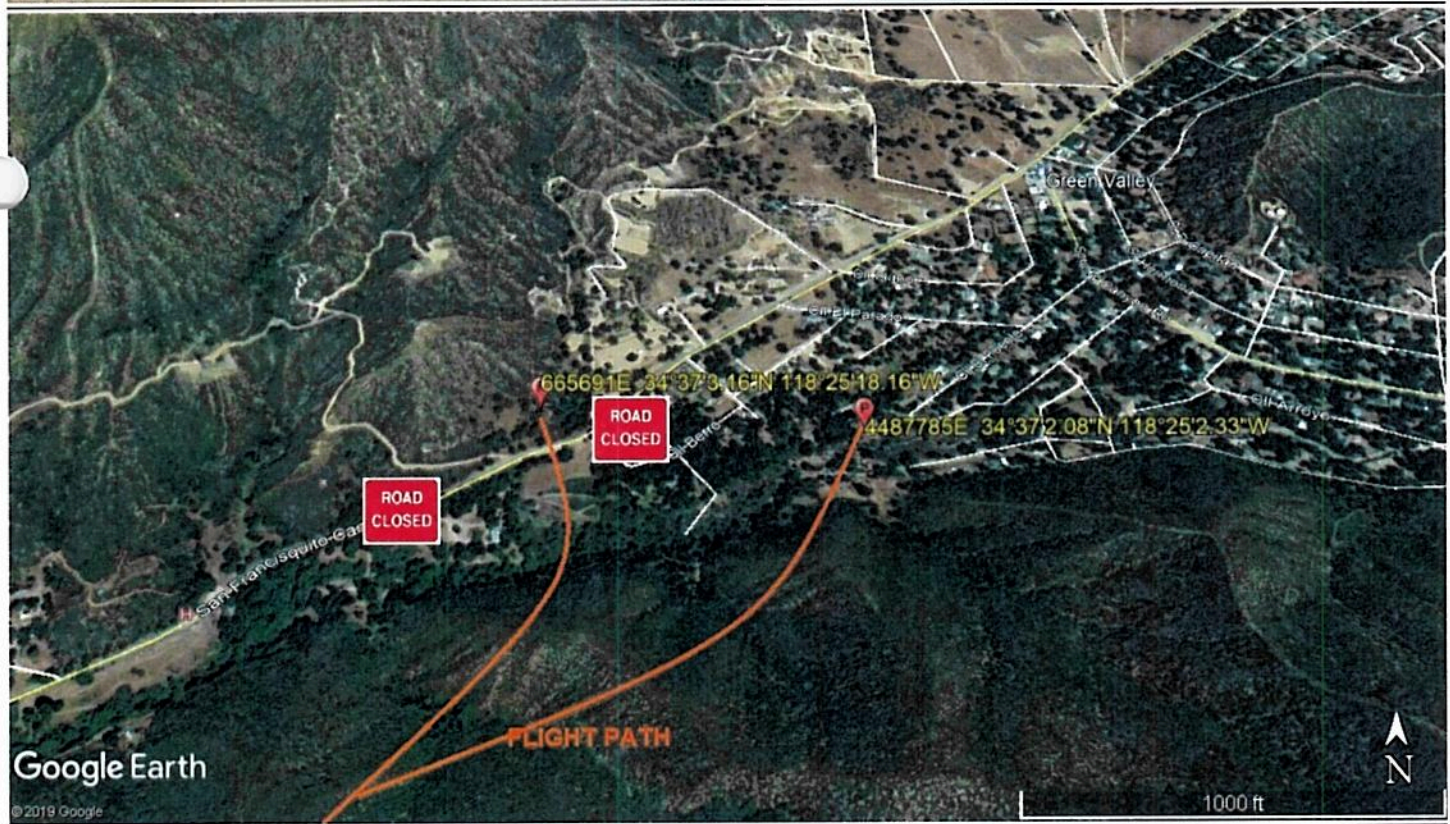
1. HELICOPTER WILL LAND AT THE LZ TO CONNECT THE LONGLINE AND CONDUCT A SAFETY TAILBOARD
2. POLE WILL BE STAGED AT THE LZ
3. FUELING WILL BE CONDUCTED AT THE LANDING ZONE
4. EMERGENCY LANDING ZONE IS AT THE STAGING AREA AND ALONG THE FLIGHT PATH
5. RADIOS WILL BE PROVIDED TO EACH POLE SITE
6. WATER TRUCK REQUIRED AT LANDING ZONE
7. SAN FRANCISQUITO CANYON ROAD AND CI EL FUENTE WILL EXPERIENCE INTERMITTENT CLOSURES
8. SEE DIAGRAM FOR STREET CLOSURE AND FLAGMAN REQUIREMENTS.
9. THE CONTRACTOR WILL TRIM TREES IF REQUIRED

THE HELICOPTER WILL LAND AT THE LANDING ZONE CONDUCT A SAFETY BRIEF AND WHEN THE LINEMAN ARE READY THE STREET CLOSURE AND GROUND CREW WILL KNOCK ON DOORS TO VERIFY VACANCY. WHEN THE LINEMAN ARE READY THE STREETS WILL BE CLOSED AND IF REQUIRED THE HELICOPTER WILL FLY TOOLS AND CARGO TO THE POLE SET SITES. WHEN THE LINEMAN ARE READY FOR THE NEW POLES THE HELICOPTER WILL FLY THE POLES FROM THE LANDING ZONE TO THE POLE SET SITES. WHEN THE LINEMAN ARE READY TO REMOVE THE OLD POLES THE HELICOPTER WILL FLY THE OLD POES FROM THE POEL SET SITE TO THE LANDIN ZONE. WHEN COMPLETE THE HELICOPTER WILL FLY THE TOOLS AND EQUIPMENT OUT OF THE SITE. THE HOMES AND STREETS WILL OPEN WHEN THE HELICOPTER IS CLEAR.





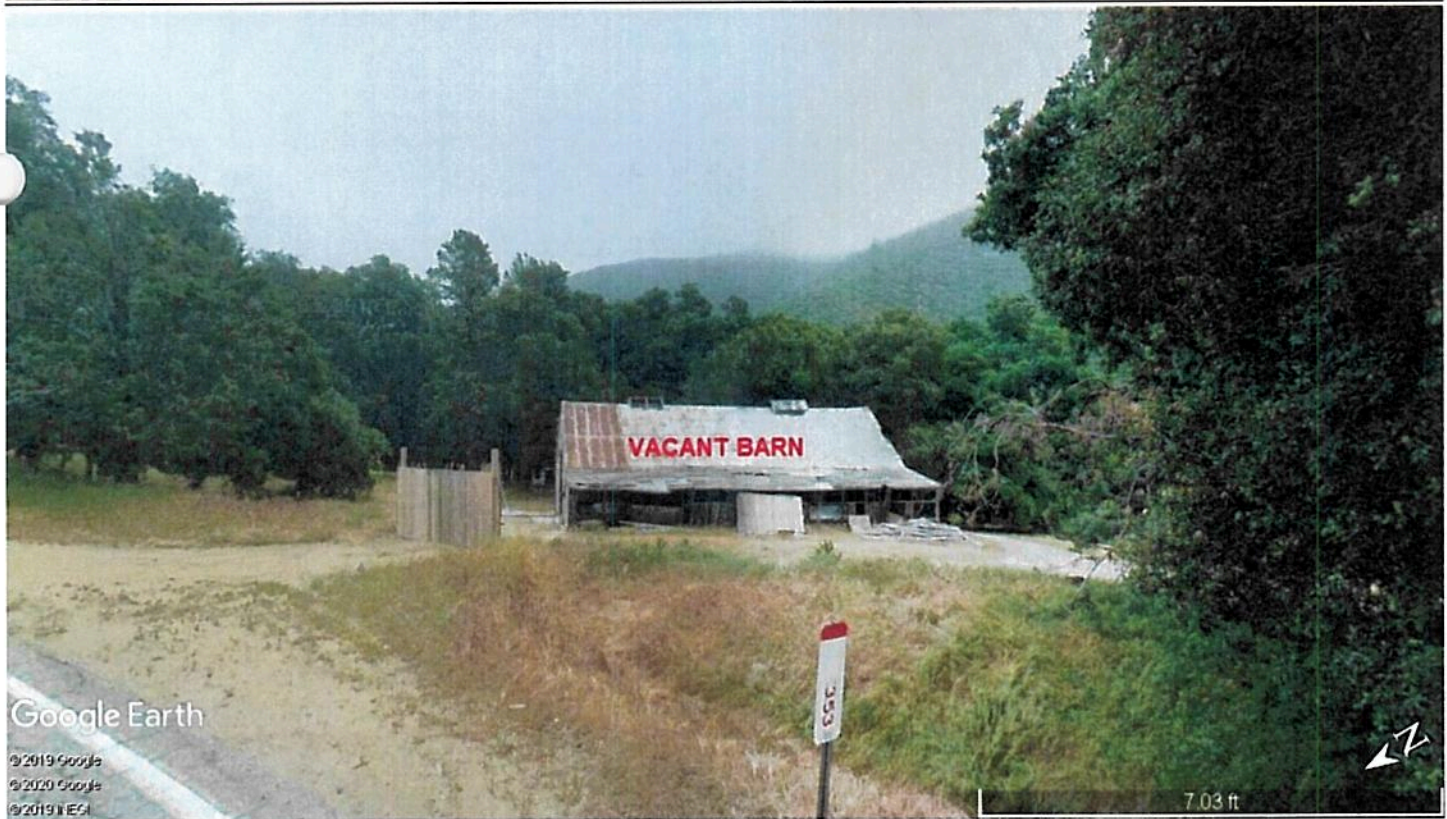

We will be working in your neighborhood to upgrade its electrical facilities to provide you a modern and reliable power grid. Your safety is our highest priority during this construction activity. We apologize for any inconvenience this may cause and will make every effort to minimize potential impacts during construction activities. Thank you for your patience as we complete these upgrades for you.

Upgrades in Your Area

We will be using a helicopter to set new utility pole.

What to Expect

- **Federal Aviation Administration regulations require we take certain precautions to ensure the safety of the public during our operation. To do this your residence must be completely vacated while the helicopter sets the new utility pole. At no time will our helicopter over fly any residence with a load attached.**
- **SAN FRANCISQUITO CANYON AND CII EL FEUNTE / CII CASCADA WILL EXPERIENCE INTERMITTENT CLOSURES DURING OPERATIONS**
- Guardian Helicopters primary concern during this operation is the general safety of the general public. We recommend measure to ensure the safety and control of any livestock during the period of helicopter operations.
- Work Timeline*
 - Date: 2-24-2020
 - Hours: 8:00 a.m. – 6:00 p.m.

The timeframe for the evacuation is approximately 120 minutes once all residents have left.

A Guardian Helicopter Inc representative will make contact with you and/or any responsible persons at your residence with further instructions shortly before the aircraft operation is to take place. Please notify all family members, workers, or anyone who may be at your residence on this date of the evacuation. It is important to us that our activity presents as little inconvenience to you as possible.
