The approved date of operation is schedule to commence and cease on August 7, 2020, between the hours of 0609 and 1947 in a secure area, as defined in the CAP.

The secure area must be strictly, maintained with only the personnel and vehicles that are directly involved with the lift operations, in the secured area. Failure to maintain a secure operational area will be grounds for cancellation of this operation.

Particular attention must be paid to clearing any debris in the attachment area and securing work materials that may be disturbed by helicopter rotor wash.

This approval is contingent upon any authorization and/or permits required by State of California or local authorities. Inspectors from this office may monitor the operation to ensure compliance with the approved plan.

DURING THE LIFT EVOLUTION THE AIRCRAFT AND GROUND CREW WILL ALL BE IN RADIO COMMUNICATIONS. IN THE EVENT OF LOSS COMMUNICATIONS THE CREW WILL USE STANDARD HAND SIGNALS TO COMMUNICATE


WITH THE PILOT. WHEN THE PILOT IS CLEAR HE WILL MOVE THE AIRCRAFT TO A SAFE LOCATION TO ALLOW THE COMMUNICATION PROBLEM TO BE RECTIFIED.

THE OPERATIONS AREA IS WITHIN THE SECURED AREA. ALL ESSENTIAL CREW WITHIN THE OPERATIONS AREA WILL NOT BE INVOLVED IN TAKING PICTURES OR ANY OTHER USE OF CELL PHONES.

A TAILBOARD SAFETY MEETING WILL BE HELD AT THE ASSIGNED AREA PRIOR TO BEGINNING HELICOPTER OPERATIONS

- 1. GROUND CREW WILL ARRIVE AT SITE TO CONDUCT AN INSPECTION TO DETERMINE THE SECURE OPERATING AREA IS PREPARED
- 2. THE GROUND CREW WILL RIG THE NEW AND OLD UNITS FOR LIFTING
- 3. THE HELICOPTER WILL LAND AT THE ASSIGNED LANDING ZONE AT APPROX 0730
- 4. THE SUBJECT BUILDING, PARKING LOT WILL BE VACANT.
- 5. AFTER CONDUCTING A TAILBOARD SAFETY BRIEF THE GROUND CREW WILL VERIFY THE MALL IS UNOCCUPIED. ,
- 6. SECURITY WILL BE RESPONSIBLE TO ENSURE THE INSIDE OF THE MALL REMAIN VACANT DURING THE OPERATIONS
- 7. THE PARKING LOT WILL BE CAUTION TAPED OF TO ENSURE IT REMAINS CLEAR
- 8. GHI GROUND CREW WILL VERIFY OPERATING AREA IS STERILE
- 9. THE GHI GROUND CREW AND PILOT WILL BE IN RADIO COMMUNICATIONS DURING THE OPERATIONS
- 10. CUSTOMER WILL ENSURE OPERATING AREA REMAINS STERILE
- 11. EMERGENCY LANDING ZONE IS AT THE STAGING AREA AND ON THE ROOF TOP HELIPAD
