The SCE Government Land Agents will submit the form to the Forest Aviation Officer (FAO) and Forest Lands Program Manager at least **72 hours prior to the aircraft use**. The FAO will submit the approved notification to the Emergency Command Center (ECC) allowing for coordination and notification to any other aviation activities on the Forest during the proposed times, enhancing safety and meeting our obligation to meet Forest Service guidelines.
